





Punter's Call

Breakout on cards

December 19, 2025

The Nifty saw a flat to positive opening and strong buying interest from lower levels but failed to close above 26000 where the highest open interest is built upon the call side. Once the index sustains above 26050, it will see sharp short covering moves towards fresh highs of 26500/26800. The Bank Nifty has been trading in a broad range between 58700-59700 and a break on either side will have trending moves in the index. The index remains in buy on dip mode as long as it holds above 58700. The broader market strength was visible with advance decline ratio in favour of advances by 2:1.

Other technical observations

On the daily chart, Nifty is trading above the 20-day moving average (DMA) and the 40-DEMA of 25993 and 25839, respectively. The momentum indicator has a positive crossover on the daily chart.

On the hourly chart, Nifty is trading above the 20-hour moving average (HMA) and the 40-HEMA of 25867 and 25903, respectively. The momentum indicator has a positive crossover on the hourly charts. The market breadth was negative with 2194 advances and 944 declines on the National Stock Exchange.
