### **Broader market weakness**

The Nifty opened negative and is consolidating in a very narrow range between 24750 and 24850, indicating rangebound expiry in today's session. The index breaks the support of 24500 can witness aggressive selling pressure towards 24500, where put writers are active. The Bank Nifty too is consolidating in a narrow range and is unable to surpass the resistance of 56000, which is acting as a strong hurdle. The broader market is very weak with an advance-decline ratio in favour of declines.

On the hourly chart, Nifty is trading below 20 and 40 EHMA i.e., 24853 and 24862, respectively. The hourly momentum indicator has a negative crossover, indicating negative momentum. The market breadth is negative with 613 advances and 2007 declines on the National Stock Exchange (NSE).
