### **Punter's Call**

#### Silver - Bullish trend Intact

As per daily chart, Silver traded positive up by +1.85% in today's trading sessions. The metal witnessed profit booking pressure, in yesterday trading sessions down by 1.85%. At present, the metal price is currently trading near the upper boundary of the channel at Rs 148,724 level this indicates strong bullish momentum in short to medium term. A sustain breakout above Rs 148,724 level can trigger fresh momentum towards Rs 150,000 & Rs 152,000 level target in near term. The key support is identified at Rs 146,850 level. Any minor degree pullback shall be considered as buying opportunity until price is trading above its support. The MACD is at overbought zone, hinting further upside strength in the counter in upcoming trading sessions.



### Natural Gas - Trendline Breakout

MCX Natural Gas price traded positive by forming higher high higher low formation along with upward trendline breakout indicates short term trend is bullish. The price has taken support on downside at Rs 297 level. The key resistance is placed at Rs 312 level. A break above this level may trigger further upside towards at Rs 321 & Rs 337 level in near term. The MACD indicator shows a positive crossover, strengthening the continuation of bullish trend.



### **Copper - Upside Potential**

MCX copper traded positive by +0.59% in today's sessions, indicating a bullish trend. The formation of higher high higher low and upward trendline breakout reinforces the strength in bullish sentiment. However, the important resistance is identified at Rs 1001 level. A breakout above this level could lead to further upside with potential targets at Rs 1015 & Rs 1030 level in near term. The key support is identified at Rs 988 level. Additionally, a positive crossover is in the Macd indicator, further reinforcing the bullish outlook for upcoming trading sessions.
