## Punter's Call

### Gold – Upside Potential

MCX Gold price traded flat down by -70 points in today's trading sessions. Despite recent phase of profit booking, the price has sustained above its key support at Rs 108,560 level indicating bullish trend in the short term. The key resistance is identified at Rs 109,956 level (previous swing high). A decisive breakout above Rs 109,956 level could lead to fresh upward momentum with potential upside targets at Rs 111,614 & Rs 115,376 level in the near term. Additionally, the macd indicator is at overbought zone further supporting bullish sentiment in upcoming trading sessions.



### Natural Gas – Rising Channel

Natural Gas price traded positive, gaining around 0.48% in today's trading sessions. The higher high higher low formation within rising channel and price trading above 20 DEMA suggest short term trend is bullish. The immediate resistance is identified at Rs 278.30 level (previous swing high). A break above Rs 5698 level will confirm bullish continuation which could lead to fresh buying opportunity potentially driving price higher at Rs 283.50 & Rs 302.50 level in near term. The key support is identified at Rs 265 level (20 DEMA). The MACD indicator shows a positive crossover, strengthening the continuation of bullish trend.



### Copper – Near Support

MCX Copper price are forming lower high lower low pattern along with upward trendline breakdown indicates bullish sentiments in the market. Despite the recent profit booking, the price has taken support at Rs 895 level (20 DEMA). If the price sustains above Rs 895 level can trigger fresh upside rally targets set at Rs 912 & Rs 923 level in near term. The macd indicator is at overbought zone further supporting bullish sentiment in upcoming trading sessions.
